Director's Report May 2023

NEW INFORMATION

I am pleased to provide you with the latest updates regarding our library. The following key points highlight our recent activities and accomplishments:

1. Cataloging Training:

a. Bob has successfully completed cataloging training and will now be able to assist us in cataloging materials not already in our system.

2. New Chairs:

a. Our new chairs have arrived and been set up without any issues. We are grateful to the Friends of the Library for their generous purchase. The old chairs have found a new home.

3. Funding for Additional Projects:

 a. In a recent conversation with Amy and Katherine Brinkman of the Friends group, they expressed interest in helping us financially with more projects. I have reevaluated our remodeling project, and the revised layout is attached below. This plan incorporates a few significant changes, resulting in a significantly lower cost.

4. Upcoming Events:

a. We have scheduled new events for August and September. Isaiah Rashad will return to present his instructional program "How to write your empire plan," and Kathleen Contrino will share information on native plants.

5. Book Orders:

- a. Our account with Baker and Taylor has been reinstated, and book orders are now being processed without any issues.
- 6. Children's Festival Supplies:

a. We currently have around 100 hacky sacks in stock for the children's festival, which should suffice for this year. If necessary, we can order additional items in a timely manner.

7. Job Corp of Cassadaga Partnership:

a. We have partnered with Job Corp of Cassadaga to promote their program and receive assistance from their students when needed.

8. Knitting Club:

a. The knitting club is temporarily on pause, but due to the positive response, participants have formed their own temporary group to continue their activities.

9. Pre-K Program:

a. The Pre-K program will conclude next month. We will submit payment for the program as the school year comes to an end.

10. Jan Dekoff replies about Grant

- a. I heard back from Jan Dekoff at the library system about the potential of using construction grants towards our various projects around the library. She affirmed that these are likely to be covered in part, the library covers 25% of the total cost . We can do all projects at once or divide them up for this grant. We don't yet have details on the dates for this year's grant schedule, however, it should be released this month sometime. I've included the following items in our grant inquiry
 - i. Air conditioning replacement is applicable
 - ii. Electrical work is applicable
 - iii. Generator is applicable
 - iv. Parking lot fix potentially applicable (if we say it's a safety hazard).

11. Funding for Native American Programs in November

a. Cris and I were working to look for funding to help cover our Native American programming in November. There was some success in this. A contact of Cris' offered to potentially fund the entire month. We're working to secure this funding now.

12. Tax Funding

a. There was a delay this year in receiving our check from school taxes. However, it had just arrived today and has been deposited without trouble.

13. Large Donation
